Introduction

Under the *Local Government Act 1995*, all Elected Members of the City are required to:

- Submit a Primary Return within three months of making their declaration of office; and
- Submit an Annual Return each year by 31 August.

Each Primary/Annual Return must include details of a Council Member's:

- Real property interests
- Sources of income
- Interests in, or trusteeship of, trusts
- Interests or positions in corporations
- Debts
- Dispositions of property
- Any other discretionary disclosures

A register of these returns is available below as prescribed by regulation 29C(2)(d) of the *Local Government (Administration) Regulations 1996*.
