Introduction

In accordance with Section 5.126 of the *Local Government Act* (the Act) and Regulation 35 of the *Local Government (Administration) Regulations 1996* (the Regulations), Council Members must pass mandatory training titled *Council Member Essentials* within 12 months of their election to Council.

The City also provides additional training opportunities in accordance with Council Policy CP 1.2 (CP 1.2)

This register is published in order to comply with Section 5.127 of the *Local Government Act 1995* (the Act) and the City of Perth Policy CP 1.2 Professional Development (CP 1.2).

Section 5.127 of the Act states:

5.127 Report on training

(1) A local government must prepare a report for each financial year on the training completed by council members in the financial year.

(2) The CEO must publish the report on the local government's official website within 1 month after the end of the financial year to which the report relates.

CP 1.2 states:

Reporting

12. *Council Members' participation in Mandatory Training and Additional Training will be subject to quarterly reporting of:*

- a. Attendance at all training; and*
- b. any interstate and international travel required for attendance at Additional Training to be published on the City's website.*

By updating this register quarterly and publishing on the website, the City fulfills these legislative obligations.
